## Ameta Dealer Gold Member Program Agreement

This agreement is made between Ameta International Co., Ltd. herein referred to as "Ameta", and \_\_\_\_\_, herein referred to as "Dealer".

Whereas Dealer desires to enter Ameta's Gold Member Program and achieve Gold Member status.

### 1. Ameta Agrees to:

- A. Offer Gold Member discount price on selected products.
- B. Offer one-year extended warranty on:
  - AiBase products: AiBase IP Camera, HDCVI Camera, NVR, XVR, Intercom, and PoE switch, purchased while holding active and valid Gold Member status.
  - Eyeonet products: Eyeonet IP Camera, HDTV Camera, NVR, DVR purchased while holding active and valid Gold Member status.
- C. Offer free Canada-wide ground shipping for orders over \$800 before taxes and \$10 flat rate on orders under \$800 before taxes. Cables, Door operators and other items specified "no free shipping" are excluded.
- D. Offer priority technical support, including:
  - Gold Member tech support priority line.
  - Scheduled product training and customized project/solution design.
- E. Offer dedicated marketing support including:
  - Monthly end-user oriented digital materials, with dealer's company logo and contact info added upon request.
  - Demo offer for the latest products.
  - Welcome package and quarterly package valued over \$200.
- F. Offer project and client referrals based on physical location to Dealer, in line with signed referral agreement.
- G. Offer Gold Member rebate in accordance to the following conditions:
  - 2% rebate of annual purchase for new customers (customers who open a business account with Ameta within one year prior to the membership start date).
  - 3% rebate of year over year in annual purchase amount for existing customers (customers who opened a business account with Ameta more than one year prior to the membership start date).

Rebate will be issued as account credit at the end of annual membership cycle.  
The annual membership cycle starts from the date of membership registration.

**2. Dealer Agrees to:**

- A. Enroll in Gold Member program with a non-refundable annual member fee of \$199.

**3. Terms and Conditions:**
